- 1. Rob Hayes, Chair of RPSD called the meeting to order at 5:00 pm.
- 2. Larry Townsend informed that he is Robert Singleterry's proxy.
- 3. Rob Hayes stated that we are short on papers for RPSD 2010. Hayes mentioned that selected papers will be published in NT. Hayes asked everyone to encourage their colleagues to submit an abstract for RPSD 2010 if they are working on projects related to RPSD 2010 topics.
- 4. A motion was made by John Hendricks to have money set aside for extension cords and to make payment to Eric Shores for any other expense related with the extension cords (seconded by Rob Hayes). The motion passed.
- 5. Charlotta Sanders mentioned that ANS changed their system for paper submission and review. The new system is intended to be user friendly.
- 6. Scott Mosher presented the Treasurer's Report. It was stated that we should be receiving \$3,000 from RPSD 2009, and that we would have received more if we

- had not spent extremely on students. Mosher will be sending a disbursement form to ANS for an expense in the amount of \$300 to be paid to the RPSD executive committee student member, Shaheen Dewji. The Treasurer's Report was approved. The revised Treasurer's Report is attached.
- 7. Rob Hayes asked for volunteers for the RPSD standards committee chair. Arzu Alpan will be the chair, Charlotta Sanders will be the co-chair, and Dick Amato will be in the committee.
- 8. Charlotta Sanders asked for feedback on student metrics: some ANS divisions give money to students who attend the ANS National Meetings based on the distance of travel. The Student Section has made a proposal for this rule to be changed so that money is distributed more evenly. Currently, RPSD is not giving money to the Student Section for student travel support. John Hendricks made a motion to be in favor of the students' proposal (seconded by Arzu Alpan). The motion was unanimously passed.
- 9. Arzu Alpan stated that there is only one RPSD student as primary author among the RPSD session papers in the 2009 Winter Meeting. In order to promote RPSD students to submit a summary and present in RPSD sessions in ANS National meetings, Alpan made a motion to award RPSD students who are first authors of summaries submitted to RPSD session, and who present the work in RPSD sessions to be awarded \$50 per student. After further discussions, the amount of the award was changed to be up to \$100 per national meeting, which will be shared based on the number of RPSD students who are primary authors and present the work (seconded by Dave Court). The motion was passed.
- 10. ANS wants to see all professional division websites standardized. Currently, Eric Shores is helping with the RPSD website. John Hendricks made a motion to allocate \$1,500 for the RPSD website development by a professional. The motion was passed unanimously.
- 11. Students from the University of Michigan gave an update on the 2010 Student Conference. The website is at www.studentans2010.org.
- 12. Rob Hayes nominated Nick Tsoulfanidis for the Rockville Lifetime Achievement Award. He would be awarded at the 2010 topical. 8 members were in favor, 1 member opposed, and 2 members abstained. The motion was passed.
- 13. John Hendricks announced the RPSD 2010 candidates:
